Call to Order, Announcement of Quorum & Note of Conflict of Interest: P. Turgeon then gave an update on Board programs and activities, including the YouthWorks Year Round and Summer jobs programs, the regional blueprint implementation (and priority sector workforce consortia), as well as new grant projects, the career center certification and monitoring effort, and the career center operator selection status.

- J.
